At a time of social and economic uncertainty and preparation of the next generation of EU-funded programmes to foster economic recovery, the Atlantic Strategy Committee (ASC) have worked to develop a revamped **Atlantic Action Plan** to give new impetus to the Atlantic maritime strategy. Based on four pillars (Ports as hub of Blue economy, skills and ocean literacy, marine renewable energies and resilient coasts), the Action Plan aims at reinforcing cooperation in this area and contributing to the European Green Deal, a socially inclusive model of sustainable development and job creation, while safeguarding marine and coastal environments and securing a healthy ocean. This event aims to highlight the lessons learnt from the past Atlantic Action Plan and other experiences of intergovernmental strategies and identify opportunities and challenges for an ambitious future for the Atlantic cooperation.
