- European Research Area European Higher Education Area


Trends 2018 – tentatively Nov. 2018

% higher institutions that implemented learning outcomes for all study programmes




- Bachelor-Master degrees

- Modularisation, learning outcomes, student-centred learning &
- Mobilities (international, workbased learning, internships)
- shared study courses

Institutional capacity for change

- importance of leadership and strategies (86%)
- who is teaching? Recognition of teaching
- support structures, resources (learning centres 65%)
- innovation driven by individual teachers/ staff, departments
- external collaboration on

learning & teaching

- employers (90%)
- local community (88%)
- primary and secondary schools (87%)
- vocational institutions (73%)
- international staff and student exchanges (96%)


teacher training / pedagogical development

- none (10%)
- national initiatives (55%)
- international initiatives (53%)
- university networks (43%)
- individual partner institutions (43%)
- commercial providers (13%)



Outlook

LLL in 2010



- No blueprint for HE innovation
- Transformation of learning and teaching:
 - gradual change rather than fast disruption
 - diversity between (missions) and within institutions (disciplines, professions)
 - flexible learning focus on LLL
 - link to research interdisciplinarity
- Importance of top-down support and soft-coordination
- Implications for higher education institutions? The teaching profession?
- Exchange and collaboration in the HE sector and with other stakeholders
- Importance of EU funding (Horizon 2020, Erasmus+)
- Next round of the Bologna Process:
 - Focus on learning and teaching
 - Partnership between governments & HE sector
 - Higher education values: autonomy, academic freedom, participation of staff and students
