## Towards Sustainable Tourism in the Maritime and Coastal Regions of Europe

Perspectives on the recovery from the Covid-19 crisis and beyond

07.07.2020 – 09:15-12:15 CEST

Europe has become the world's number one destination for international arrivals and Tourism creates a surplus for its economy, accounting for more than 10 percent of the EU's GDP and 12 percent of jobs. Tourism can be thus a powerful tool in fighting economic decline and unemployment, mostly among the youth and in peripheral and maritime areas. Nevertheless, the sector is and has been facing a series of important challenges, in terms of demographic and environmental pressures, use of resources, waste and water management or seasonality. Nowadays, Tourism is being especially affected by the current crisis, mainly due to travel and lockdown restrictions imposed to slow down the spread of COVID-19.

This online seminar is organised in the framework of the activities of the [Seas, Rivers, Islands and Coastal Areas Intergroup](#) of the European Parliament, Searica, with the support of the [Conference of Peripheral Maritime Regions](#) (CPMR) and the [Travel Foundation](#). It will address the impact of the COVID crisis on the Maritime & Coastal Tourism sector in regions of different sea basins of Europe and address the potential way forward, towards a full smart and gradual recovery. The discussion will involve Members of the EU Parliament and in particular of the SEARICA Intergroup and the Task Force on Tourism of the EP Transport and Tourism Committee. Representatives of the European Commission will also join the debate, together with representatives of CPMR Regions coming from different sea basins of Europe and key players of the tourism sector that can provide valuable inputs and experiences

The workshop builds on the reflections for the forthcoming implementation of the new EU Green Deal in relation with Tourism and at the same time on the perspectives of the new EU Multiannual Financial Framework, currently under negotiation. It will also address the implementation of the “Coronavirus Response Investment Initiative” and of other relevant measures adopted, such as the package of guidelines and recommendations on Tourism in Europe in 2020 and beyond and the recently announced EU website on safe holiday options. On the one side, the webinar should focus on the livelihood impacts of the crisis, and prospects for employment and recovery of business activities in the Coastal and Maritime tourism regions. On the other, it should address long-term sustainability issues, the integration of environmental impact management and decarbonization methods and measures into a new policy design for tourism management which leverages multilevel governance dynamics towards a truly smart and sustainable recovery.

The webinar will try to answer, among other questions, how sustainable tourism can form an essential component of the EU Green Deal and how the EU Green Deal can boost the recovery of the tourism sector. The debate among key stakeholder will also contribute to build solid reflections in view of the “Tourism Summit” that the European Commission has recently announced for the last trimester of 2020.
