As the EU shapes its future Port Strategy, it is time to recognise the strategic role of ports as more than gateways. They are the engines of economic growth, green innovation, and connectivity across Europe's coastal and maritime areas. They are platforms for industrial activity, job creation, green innovation, and connectivity, especially in peripheral, island and outermost regions that rely on maritime access to connect with the rest of Europe.

Ports also have growing relevance for Europe's resilience and defence. Planning for dual-use capacity, secure supply chains, and maritime corridors requires joined-up thinking across sectors and territories. Crucially, ports are enablers of the green transition. Their role in supplying alternative fuels, hosting clean energy, and driving modal shift hinges on smart investment and coordination, especially in areas positioned to lead on hydrogen, offshore wind, or ship recycling.

To deliver on these ambitions, EU funding instruments, and in particular the future Connecting Europe Facility which defines ports as cross-border infrastructures, will have to guarantee fair access for all actors, especially smaller or less-central ports. The proposed envelope for the CEF remains subject to ongoing negotiations on the next Multiannual Financial Framework. It is still uncertain whether it will provide the necessary means to fully support the adaptation of ports and help build strategic maritime economic zones coupling logistics, industry, defence preparedness and innovation.

In this timely political moment, MEP **Nina Carberry**, SEArica Vice-Chair, warmly invites you to join the discussion and help shape a European future that truly unlocks the full potential of our ports for the benefit of our coastal communities, citizens, and all of Europe.
