### Format:

The event will be organized in an online interactive format, as a virtual exchange between members of the EU Parliament, representatives from CPMR coastal and insular regions belonging to different sea basins of Europe, the European Commission and key territorial stakeholders.

It will be broadcasted to all interested stakeholders willing to attend the webinar.

### **Objectives**:

- jointly assess the situation of the tourism sector in the EU coastal regions after the conclusion of the summer season in relation with the progressive way out of the pandemic crisis.
- feed the medium-long term reflection on an EU strategy for Sustainable Tourism towards a smarter, greener and more resilient sector
- contribute to the EC targeted consultation on "Scenarios towards co-creation of transition pathway for tourism for a more resilient, innovative and sustainable ecosystem"
- reflect on Sustainable Tourism and integrated management in the Islands, capitalize results from EU projects into policy and look into new cooperation opportunities.

Exchanges will be meant to inform and support the policies and the concrete actions of the EU and the regions regarding Sustainable Tourism, also in view of the COP26 and the Conference on the Future of Europe.



### Key Topics that will be addressed:

- Assessment of the summer season from the point of view of issues, challenges and tendencies encountered at territorial level, related to the volume and quality of tourism (including the impact on the ecosystems/natural assets) and the implementation of health measures due to the pandemic,
- EU funding opportunities for Sustainable Tourism, state of play on the inclusion of priority actions on tourism in the National Resilience and Recovery Plans and involvement of the regions,
- Long term reflection related to key recommendations arising from the EP 2021 INI report on a EU strategy for sustainable tourism, the conclusions of the EU Council in May 2021 on "Tourism in Europe for the next decade: sustainable, resilient, digital, global and social" and the output of the 2020 EU Tourism Convention.
- CPMR and regions answers to the EC's consultation on scenarios towards co-creation of transition pathway for tourism.
- Capitalization of results of WINTER MED (Interreg MED) project on an integrated transnational strategy for the development of all year round sustainable and responsible tourism in Mediterranean island destinations.
- New opportunities of collaboration such as emerging pilot project proposals from the EU Parliament.

<u>Background</u>: the event follows up on a previous SEArica virtual political event organized in July 2020 by the CPMR and the Travel Foundation that involved representatives from EU Institutions as well as hundreds of stakeholders from the public and private sector and on a technical event organized by the CPMR with its Geographical Commissions in the framework of the 2021 European Maritime Day, which focused particularly on Sustainable coastal tourism and the identification of key actions towards a smart and resilient recovery, counting on the participation of more than 500 stakeholders from all EU sea basins.
